CANCELLATION POLICY

By reserving your space through placing your deposit with us, you are agreeing to the stated policies in our Agreement.

Your deposit is non-refundable. If cancellation takes place more than 90 days prior to departure you will be fully refunded minus your deposit. If cancellation takes place between 60-90 days of departure, 50% of payments made will be refundable. Should cancellation occur within 60 days of departure all payments will be forfeited.

We strongly encourage you to purchase trip insurance for this retreat, and recommend the "cancel for any reason" option, to protect your deposit and payments made should you cancel your participation in this retreat.

TRAVEL DOCUMENTS
